Follow the steps below **before** your immigrant visa interview at the U.S. Consulate in Auckland, New Zealand. After you receive your visa interview appointment, complete each of these steps below.

If you do not complete each step *before* your visa interview appointment the consular section may require you to reschedule for a later date.

All applicants must follow the instructions below before going to the U.S. Embassy or Consulate.

Step 1: Register Online

Before your visa interview appointment, you must register online [here](#). Your registration ensures we have the correct information to return your passport and documents after your visa interview. Registration also allows you to cancel or reschedule your interview if necessary.

Step 2: Schedule a medical exam in New Zealand

As soon as you receive your appointment date, schedule a medical exam in New Zealand. Click the "Medical Exam Instructions" button below for a list of designated doctors' offices in New Zealand. Schedule and attend a medical exam with one of these doctors before your interview.

Step 3: Bring documents to the consulate **BEFORE** your interview

Provide all required original documents and any missing items to the U.S. Consulate General in Auckland **before** your interview. We've created a checklist that will tell you what to bring. Print the checklist below and bring it with the listed documents to the consulate the week before your interview any time between 8:00 a.m. and 12 noon Monday through Friday, except public holidays. Place everything in a single envelope with your case number and full name on the outside. Address it to "Immigrant Visa Unit".

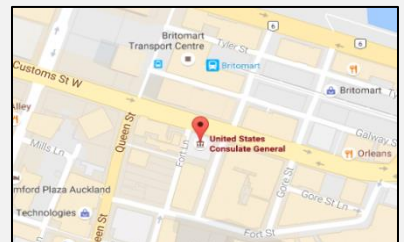

Medical Exam Instructions

All immigrant visa applicants, regardless of age, require a medical examination prior to the issuance of a visa. Only a physician accredited by the U.S. Consulate can perform this exam. **It is your responsibility to schedule a medical exam with one of the doctors listed below at least two (2) weeks before your visa interview** appointment at the U.S. Embassy. Medical examination results from other physicians will *not* be accepted.

Items to bring to your medical examination

Any medical examination fees, including x-ray and blood test fees, must be paid directly to the examining physician. Medical fees are not paid by the U.S. government. Please take the following items to your medical exam:

- Your visa interview appointment letter,
- Your passport,
- Six (6) recently taken passport-sized color photographs,
- A copy of your immunization records, and
- A copy of the [medical exam form](#) that can also be found at the end of this page.

During the medical exam

The medical exam will include:

- A medical history review,
- A physical exam,
- A Chest X-ray,
- Blood tests (for applicants 15 years of age or older),
- Gonorrhea testing (for applicants 18–24 years of age, or as needed)
- Tuberculosis testing (for applicants two years of age and older).

Your examining physician may request other tests if they think they're needed. Be prepared to discuss your medical history, the medications you are taking, and current treatments you are receiving. U.S. immigration law requires immigrant visa applicants to get certain vaccinations prior to the issuance of a visa. Current immigrant visa vaccination requirements are available on [CDC.Gov](#). There you can find information on [what vaccines you need](#) based on your age. You can also read Frequently Asked Questions about our medical exam requirements at [Travel.State.Gov](#).

Medical Exam Instructions



After the medical exam

When your examination is completed, the doctor will send the report directly to the U.S. Consulate. Any x-rays taken will be given to you. You **DO NOT** need to bring the x-rays to your visa interview unless you suffer from tuberculosis (TB). However, you **must** carry the x-rays with you when you travel to the United States for the first time. The medical report **must** be less than six months old when you enter the United States as an immigrant.

Pre-Interview Checklist ☒



Use the list below to determine the items that every applicant must provide to the consulate before the immigrant visa interview. Bring your documents to the consulate the week before your interview any time between 8:00 a.m. and 12 noon Monday through Friday, except public holidays. Place them in an envelope with your case number and full name on the outside and addressed to "Immigrant Visa Unit."

Any documents that are not in English must be accompanied by a certified English translation:

- ☐ A copy of your NVC interview letter (does not apply to Diversity Visa, fiancé(e), adoptive, or asylee/refugee applicants).
- ☐ A photocopy of the biographic page (where your name and photo are located) of your passport. You will need to bring the original unexpired passport, valid for a minimum of six (6) months beyond your intended date of entry to the United States.
- ☐ Two (2) color passport-size photographs of each person applying for a visa (5 cm x 5 cm, or 2 inch x 2 inch). Review our [online photo requirements](#).
- ☐ Confirmation page from the Form DS-260 Application for an Immigrant Visa you submitted online at ceac.state.gov/iv.
- ☐ Your **original** birth certificate *and* a photocopy.
- ☐ Original or certified copies of birth certificates for all children of the principal applicant (*even if he or she is not accompanying*).

Applicants who fall into any category listed in italics below should bring these additional documents:

For family-based visa applications:

- ☐ The appropriate [Form I-864 Affidavit of Support](#) for **each** financial sponsor along with a photocopy of the sponsor's IRS transcript or most recent U.S. federal income tax return, and any relevant W-2s.
- ☐ Proof of your U.S. petitioner's status and [domicile](#) in the United States (photocopy of a U.S. passport, naturalization certificate, or lawful permanent resident card).
- ☐ Evidence of the relationship between the petitioner and visa applicant (such as photographs, letters, or emails).
- ☐ *If you are married:* Your **original** marriage certificate and a photocopy.
- ☐ *If you were previously married:* Your **original** divorce or spouse's death certificate, and a photocopy.
- ☐ *If you are older than 16 years old:* The **original** police certificate from your country of current residence and countries of previous residence. If these three items are **all** true, bring a more recent police certificate to your interview:
 - If you are older than 16 years,
 - If you obtained a police certificate and submitted it to NVC more than one year ago, and
 - If you still live in the country that issued the police certificate.
- ☐ *For employment-based visa applications:* Letter from your U.S. employer dated less than one month ago.
- ☐ *If you have ever been convicted of a crime:* Court and criminal records, and a photocopy.
- ☐ *If you have served in any country's military:* Military records and a photocopy.
- ☐ *If you are adopted:* Adoption papers or custody documents and a photocopy.
- ☐ *If you are the petitioner's stepchild:* The **original** marriage certificate of the petitioner and your biological parent, and a photocopy along with divorce records for any previous marriages of either parent.

Interview Guidelines



Sending documents to the U.S. Consulate

If the U.S. Embassy requests additional information or documentation from you, the consular officer will provide instructions on how to submit those to the embassy following your interview.

Rescheduling or cancelling your interview

If you are unable to attend your appointment, please email aucklandiv@state.gov as soon as possible. **There may be a significant wait before the next available appointment**, so please attempt to attend the date already assigned. For some family-based and employment preference visa categories, a visa became available within the month you have been scheduled by NVC. DV applicants should be aware that visas are numerically limited and must be issued by September 30 of the program year. **There is no guarantee that a visa will still be available on the date of your rescheduled interview.** Please carefully consult the [Visa Bulletin](#) before you request to reschedule your interview.

Security screening procedures

All visitors to the U.S. Consulate in Auckland must follow certain security procedures. Any visitor who declines to be screened by U.S. Consulate security personnel will be unable to enter the consulate. You are not allowed to enter the U.S. Consulate while carrying any battery-operated or electronic devices, large bags or luggage, or food and liquid items. To avoid delaying your entry and that of those in line behind you, please bring only what is required for your interview.

Accompanying persons

The following people may accompany a visa applicant to their interview:

- Interpreter: Applicants may bring ONE interpreter if they do not speak English well enough to participate in an interview.
- Special Needs Visitors: Applicants may bring ONE person to help if they are elderly, disabled, or a minor child.

Attorneys are **not** permitted to accompany clients into the waiting room or to their interview.

Immigrant visa fees

If you have not paid all required fees to the National Visa Center, please be prepared to pay these fees on the day of your interview. All fees may be paid in either U.S. dollars or the New Zealand dollar equivalent. We accept cash and credit cards only. *Please note that if you are found ineligible to receive a visa, the application fee cannot be refunded.* You can find a complete list of fees on our [Fees for Visa Services webpage](#).

Do not make travel plans outside of New Zealand

If your visa is approved, we will keep your passport at the consulate while we prepare your immigration packet and print a visa for your passport. We will return your passport to you later via courier services only. If you have to travel within New Zealand while your passport is still with us, please make sure you have a valid picture ID other than your passport.

After Your Visa Interview



A consular officer can decide on a visa application only after reviewing the formal application and interviewing the applicant. ***There is no guarantee that you will receive a visa.*** Do not quit your job, sell your property, or make non-refundable travel arrangements until you have received your immigrant visa.

If more information is needed

Sometimes a consular officer refuses a visa application to review **additional documents** or for **administrative processing**.

For additional documents:

- The consular officer will give you a refusal letter that asks you to submit additional documents.
- The letter will include instructions on how to submit those documents to the consulate.

For administrative processing:

- This means the consulate needs more time to review your case.
- How long this takes depends on your specific situation.

Wait **at least** 60 days after your interview before asking about your application status.

What happens after visa approval?

Passport, Visa, and Sealed Immigrant Packet – We will place your immigrant visa on a page in your passport. Review your visa to make sure there are no spelling errors. We will also give you a sealed envelope containing documents that you must give to U.S. immigration authorities when you arrive in the United States for the first time. ***Do not open this envelope. You must carry it with you; do not put it in your checked luggage.*** If you receive X-rays during your medical examination, carry those with you and give them to the U.S. immigration authorities.

USCIS Immigrant Fee – All individuals who are issued immigrant visas overseas must [pay an Immigrant Fee](#) to U.S. Citizenship and Immigration Services (USCIS) **prior to traveling** to the United States. This fee is for processing your residency status and printing your Permanent Resident Card. The only people exempt from paying this fee are: children entering the United States under the Hague Process, returning residents, and people traveling on a K visa.

When You Should Travel – You must enter the United States *before* the expiration date on your visa, which is usually six (6) months from the date of printing. Your visa cannot be extended and all fees are nonrefundable. The principal applicant must enter **before or at the same time** as other family members with visas. Unless they are eligible for benefits under the Child Status Protection Act, children who are issued a visa before turning 21 years of age must enter the United States **before** their 21st birthday to avoid losing their immigrant status.

Getting a Green Card – Your Form I-551 Permanent Resident Card, also known as a green card, will be automatically mailed to the address in the United States that you write in your visa application form. This is a very important document that proves you have permission to reside in the United States. *If you plan to travel outside the U.S. before your green card arrives:* Please consult [USCIS's](#) and [CBP's](#) websites for rules about what documents you need to re-enter the country. We also recommend you check with the airline to ensure you are in compliance with their rules. *Once your card is issued, you should not stay outside of the United States for more than one year. If you do, you will lose your status as a Lawful Permanent Resident.*

After Your Visa Interview



Children's Issues – In the United States, children are required to have certain vaccinations before they can enroll in school. We recommend that you bring your child's complete vaccination records with you to the United States. If your child is adopted, you have full custody as a result of a divorce, or you share custody with another parent, you should bring a copy of all applicable adoption or custodial papers from the authoritative court in your home country. You will need these papers (translated into English) for issues such as school enrollment, medical care, and eventual citizenship.

Diversity Visa Applicants – Additional Information



If you are interviewing for a Diversity Visa (DV), all of the above instructions apply to you. Please schedule and attend a medical examination prior to your visa interview, and gather the required documents.

*Below are additional instructions that apply **only** to DV applicants.*

Bring to your interview

In addition to the documents listed on the Pre-Interview Checklist in this package, DV applicants should also provide the following items prior to your visa interview:

- ☐ Appointment information printed from the “Entrant Status Check” on the [E-DV website](#).
- ☐ Documents showing that you have either a qualifying high school education **OR** have two years of qualifying work experience in the last five years immediately prior to application (for the principal applicant only; more information is available on our [Diversity Visa Process webpage](#)).
- ☐ Payment in cash of the \$330 Diversity Visa Application Fee per person.

Review your DV Program entry

Prior to your visa interview, we recommend that you review the data on your initial E-DV entry. On your initial E-DV application, you must have correctly entered your marital status. If you are legally married you must have listed your spouse, even if you are currently separated from him/her (unless your spouse is a U.S. citizen or Lawful Permanent Resident).

Additionally, you must have listed ALL of your living children who are unmarried and under 21 years old. This includes your natural children, your spouse’s children, or children you have formally adopted in accordance with the laws of your country.

Failure to have listed an existing spouse or children at the time of your entry in the Diversity Visa lottery will result in the denial of your visa and visas for your family. Any fees paid to the U.S. government in support of your visa application(s) are nonrefundable. If you failed to include a child who had already been born, or a spouse to whom you were married when you entered the lottery, you should not proceed with the visa application.
